Promotion 2020 : what should you do if...

Luxembourg, 19 novembre 2020

The 2020 promotion exercise ends with the publication of the following Administrative Notice:

The results are visible in your Sysper file, under 'Promotion'

No system is perfect. The current even less than the previous ones. As a reminder, all unions objected to it, but the Commission remained true to its 'dialogue' principle and imposed it.

In line with its mission, Union Syndicale Fédérale Luxembourg informs you on what you should do in case you did appeal but are not promoted.

The promotion committees (AD & AST) analysed all the appeals but held only had 5% of pre-assigned quotas per grade and so little room for manoeuvre to mitigate instances of injustice or discrimination.

The Staff Representation managed to obtain this year again a list going beyond those 5%, though failing to tackle all observed inequities and disparities identified in the appeals.

Your appeal was not successful? You can still introduce an 'Art. 90' complaint.
